LOCATION

The site is located on Cinder Road approximately 0.5 miles from Gornal Wood; Russell's Hall Hospital is 2 miles; Pensnett Trading Estate is 0.4 miles and Merry Hill Shopping centre is 3 miles from the site.

It is approximately 3.7 miles from the Birmingham New Road (A4123) and 5.8 miles from Junction 2 of the M5.

DESCRIPTION

The site extends to approximately 3.45 acres (1.4 hectares) and is industrial/commercial land and has been used as such for many years. Part of the site is currently used as a haulage yard.

The site includes a number of buildings in a variety of commercial uses. On site there are also a pair of semi-detached cottages that have been converted to ancillary office space.

To the west of the industrial buildings is an area of amenity land which has a number of trees and a large pond.




